FALLS CHURCH, Va., Feb. 4 – CSC (NYSE: CSC) today announced the successful deployment of a Sun Microsystems Inc. (NASDAQ: JAVA) desktop virtualization solution based on Sun Ray™ thin clients at three CSC financial services business process outsourcing (BPO) locations.
